Local Agency Program (LAP)



- ▶ Established in 1991 with the enactment of the Intermodal Surface Transportation Efficiency Act (ISTEA)
- ▶ Not a funding source, but is a vehicle by which the project is administered through.
- ▶ The LAP process can be used on any project that has federal funds.
- ▶ Authorized Local Agencies are “sponsors” of the projects and are reimbursed through FDOT.
- ▶ Can be used for project planning, project development, design, and construction of transportation facilities.



Local Agency Program (LAP)



- ▶ All LAP projects have to satisfy NEPA requirements, as well as be present in FDOT's Five Year Work Program, Transportation Improvement Plan (TIP) and the State Transportation Improvement Plan (STIP).
- ▶ Central Office LAP Administrator, with each District having its own District LAP Administrator – Keith Shores, District 3 LAP Administrator



Local Agency Program (LAP)



- ▶ A Local Agency can be a city, municipality, county, or transportation authority and can receive one of three certification types:
 - ▶ Full administration
 - ▶ Project Specific
 - ▶ Risk-Based

Transportation Investment Generating Economic Recovery (TIGER)



- ▶ TIGER I was part of the American Reinvestment and Recovery Act of 2009; TIGER II was authorized by the FY 2010 Appropriations Act; TIGER III was funded as part of the FY 2011 Appropriations Act.
- ▶ Provided for a discretionary grant program to award monies on a competitive basis for capital investments in surface transportation projects that will have a significant impact on the Nation, a metropolitan area, or a region.
- ▶ Funds come from the USDOT to FDOT for disbursement to the project sponsors.
- ▶ NEPA documentation is required, as well as inclusion in the TIP and STIP.

American Recovery and Reinvestment Act of 2009 (ARRA)



American Recovery and Reinvestment Act of 2009 (ARRA)



- ▶ Implemented to spur economic activity during the recession and to “invest in transportation, environmental protection, and other infrastructure that will provide longer term economic benefits” to the Nation.
- ▶ Funding projects via ARRA is complete.
- ▶ Over 120 ARRA projects have been implemented in District 3.



FDOT's Role



- ▶ FDOT's role with LAP, TIGER, and ARRA projects is primarily:
 - ▶ To serve as “Trustee” of the Federal funds and approves/pays invoices from the Local Agencies
 - ▶ To provide Project Oversight and Coordination





Joint Participation Agreement (JPA)



Joint Participation Agreement (JPA)



- ▶ Reimbursement agreement between FDOT and a Local Agency (no Federal funds).
- ▶ Similar to a LAP agreement, but involves State money.
- ▶ A contract (JPA) is signed between FDOT and the Local Agency.



Joint Participation Agreement (JPA)



▶ Examples:

▶ **Transportation Regional Incentive Program (TRIP)**

- ▶ Provides state matching funds (50% of project costs) for improvements to regionally significant facilities.

▶ **Small County Outreach Program (SCOP)**

- ▶ Provides partial project funds to small county governments in resurfacing or reconstructing county roads/bridges or in constructing capacity or safety improvements to county roads.
- ▶ 12 eligible counties in District 3.

▶ **Small County Road Assistance Program (SCRAP)**

- ▶ Assists small county governments in resurfacing and reconstructing county roads. Beginning in FY 2013.
- ▶ 10 eligible counties in District 3.

▶ **County Incentive Grant Program (CIGP)**

- ▶ Provides partial project funding to counties to improve transportation facilities located on the State Highway System or that relieve congestion on the State Highway System.



Joint Participation Agreement (JPA)



- ▶ **FDOT's role with JPA projects:**
 - ▶ Provide funding for selected projects
 - ▶ Depending on the JPA, prioritization and selection of projects
 - ▶ To provide Project Oversight and Coordination
