Approval of the above is requested. The following is justification/explanation of the requested actions:

This is a "no-cost" extension; therefore, no additional funds are necessary to support the services performed under this agreement modification. This amendment intends to allow NWFWMD additional time to continue to participate in the Environmental Transportation Decision Making (ETDM) process, provide expedited review and technical assistance to the Department.

The Funding Agreement (FA) between Northwest Florida Water Management District (NWFWMD), the Florida Department of Transportation (FDOT) and Federal Highway Administration (FHWA), which became effective June 6, 2011, is requesting a no-cost time extension.
