Approval of the above is requested. The following is justification/explanation of the requested actions:

The Funding Agreement (FA) between South Florida Water Management District (SFWMD), the Florida Department of Transportation (FDOT) and Federal Highway Administration (FHWA), which became effective May 15, 2007, is requesting a no-cost time extension.

This is a "no-cost" extension; therefore, no additional funds are necessary to support the services performed under this agreement modification. This amendment intends to allow SFWMD additional time to continue to participate in the Environmental Transportation Decision Making (ETDM) process, provide expedited review and technical assistance to the Department through May 14, 2018.

**Article II, Paragraph B** which authorizes reimbursement to SFWMD for a five (5) year term is amended to authorize reimbursement to SFWMD for an eleven (11) year term through May 14, 2018.

**Attachment A** which limits reimbursement to the first five (5) years of this FA is amended to 11 years.




