Approval of above selections requested. The following is justification/explanation of the requested action:					
<p>This is a two (2) year "no-cost" time extension. No additional funds are necessary to support the services performed under this agreement modification. This amendment intends to allow USFS additional time to continue to participate in the Environmental Transportation Decision Making (ETDM) process, provide expedited review, and provide technical assistance to the Florida Department of Transportation (FDOT) Office of Environmental Management (OEM).</p> <p>The Funding Agreement (FA) between USFS, Florida Department of Transportation (FDOT), and Federal Highway Administration (FHWA), which became effective August 8, 2006, is requesting a two (2) year no-cost time extension. There is "no change" in the total agreement amount of \$194,938.00.</p> <p>Article III, Paragraph A, which authorizes reimbursement to USFS for a five (5) year term, is amended to read "FDOT shall provide reimbursement to USFS for a total sum ending on August 8, 2018, or a date thirteen (13) years from the date of this FA or the signature, whichever comes later.</p> <p>Article IV, Paragraph A, which limits the term to five (5) years unless terminated sooner in accordance with Article IV.B, is amended to read "The term of this FA shall run for a period, commencing upon signature or July 1, 2006, whichever comes later and ending August 8, 2019 or thirteen (13) years thereafter, whichever comes later, unless terminated sooner in accordance with Article IV (B) below." The intent of this modification is to authorize and maintain services supporting this contract through August 8, 2019.</p> <p>In addition, Article V Project Officers (B) is amended to read as follows:</p> <p>B.
